COMMITTEE REPORTS

Architectural Review

Welcome Spring! This is the time of year when external home repairs and improvements are at their peak. Please remember to consult the Architectural Standards and submit the Homeowner Request for Approval form before starting any work.

Now that the warm weather is here, members of the Architectural Review Committee have conducted a "walk through" of the community. During the recent walk through a few violations of the Architectural Standards have been noted, specifically:

- There are still a few trash cans that remain visible to the street after trash day. Garbage cans need to be taken in as soon as possible after pick up and must be placed in garages, the rear of the homes, or behind some sort of structure so they are not visible from the street.
- Residents are using the side of their homes to store garbage cans, lawn mowers, etc.
- Several mailboxes are out of compliance with the *Standards* (p. 8). Please take a look at your mailbox and repair, paint, or replace it if needed. Also, you must make sure the house number is on the mailbox.
- No commercial vehicles or recreational vehicles (trailers, campers, boats, snowmobiles, etc.) are permitted to be parked overnight in Covington Woods or kept on any lawn at any time. Such vehicles are to be parked or stored elsewhere.

Now that the warmer weather has arrived, many residents are outside enjoying their patios, decks, and backyards. For those residents with dogs, please remember that barking dogs are not pleasant to listen to after an extended period of time. Do not leave your dog(s) tethered outdoors, or in your fenced-in yard to continually bark. Also, please keep your dog leashed and pick up its litter. It is not only a Covenant of Covington Woods, it is a Town of Guilderland Law.

It is every homeowner's responsibility to keep lawns mowed and landscaping attractive. All residents need to be aware of the Covington Woods Covenants, which require lawns to be mowed regularly and kept as weed-free as possible. Shrubs and bushes should not be allowed to become overgrown. While lawns must be adequately watered to prevent large, dry patches, residents must follow water restrictions. On June 1, 2015, the Town of Guilderland banned all lawn sprinkling until further notice. Please check the Town website to see when the ban is lifted.
